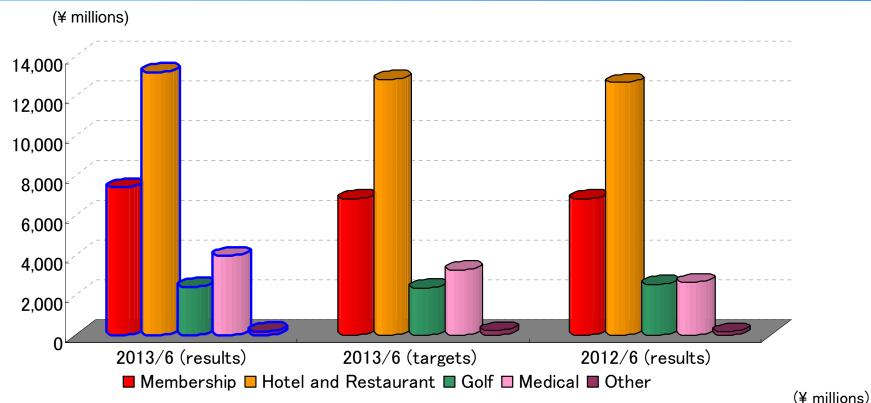

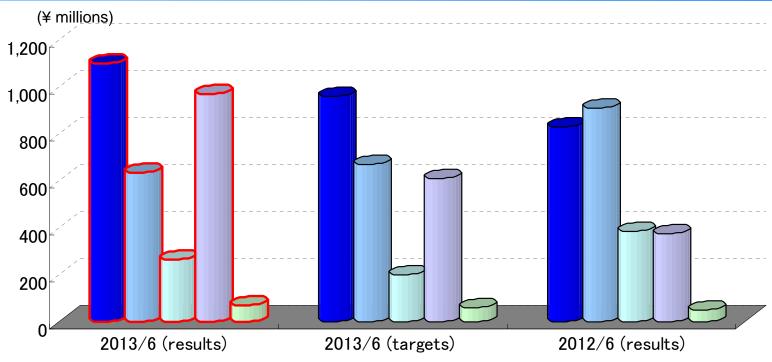

X Progress rate of the total contract amount

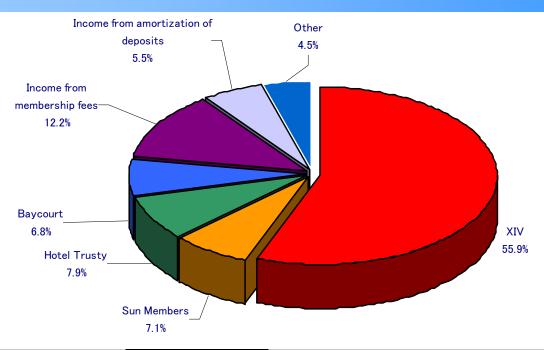

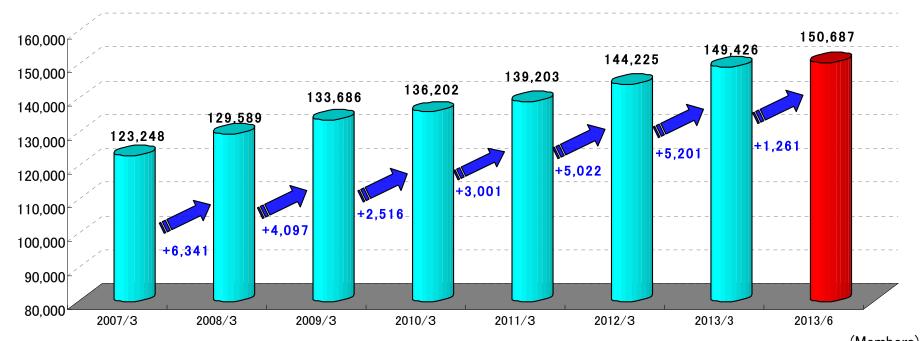

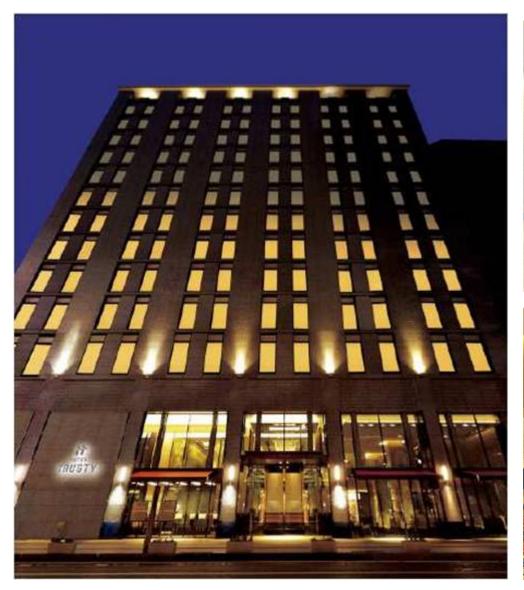
