Announcement of Opening of Exclusive Membership Resort
"LAGUNA BAYCOURT CLUB HOTEL & SPA RESORT" on Thursday, March 28

Resorttrust, Inc. ("the Company") will open the "Laguna Baycourt Club Hotel & Spa Resort" in Gamagori City, Aichi Prefecture, on Thursday, March 28. This is the third facility of "Baycourt Club" after the Tokyo and Ashiya facilities and is located in Laguna Gamagori, an integrated resort that is about a one-hour drive from central Nagoya. It is in an area with a captivating resort atmosphere overlooking Mikawa Bay.

The facility is notable for its impressive appearance with a curve reminiscent of waves along the coastline, which reaches out to embrace the ocean. Inspired by a "Futuristic Luxury" design concept, the gorgeous, burnished visual impact is emphasized in the choice of materials and the interior design. The result is a futuristic luxurious space.

There are three types of rooms, all of which are suites: "Bay Suite," "Luxury Suite," and "Royal Suite." Innovative design with curved lines on the member's room walls, ceilings, and floors creates a futuristic luxurious space with the attribute of openness. Each of the Royal Suite rooms (two rooms) located at the right and left ends of the top floor has a balcony equipped with a vibra bath where members can experience blissful indulgence while enjoying splendid ocean views.

The main dining room offers Italian cuisine in a dazzling space with a marina view. The facility also has a stately yet stylish Japanese restaurant with a teppanyaki counter and a Chinese restaurant whose glittering, dream-like atmosphere makes it seem a palace of light.

Other facilities include an outdoor spa where members can enjoy a hot spring while gazing out over the expanse of the ocean, an esthetic treatment salon with a cave motif, and a spacious swimming pool that feels connected to the ocean—all offering pleasure to your heart's content. Members can enjoy marine resort activities, such as cruising on a yacht owned by the hotel.

The Company launched the sale of memberships in the "Laguna Baycourt Club Hotel & Spa Resort" in August 2016 with prices ranging from ¥8.57 million to ¥36.36 million (including consumption tax). Progress rate of contract (cumulative) as of February 28, 2019 was about 79.8%*.
