<u>Noage International, JCB, PT Bank Danamon Indonesia Tbk Collaborate</u> <u>to Promote Medical Tourism for Indonesia's Affluent</u> Partnership Signing Ceremony for New Program to Deliver Japanese Medical Care Held in

Noage International Inc. (hereinafter, "Noage International"), a joint venture established by Resorttrust Group and Mitsubishi Corporation, has entered into a business agreement with JCB International Co., Ltd., a subsidiary of JCB Co., Ltd. responsible for overseas operations, PT. JCB International Indonesia, a local subsidiary operating in Indonesia (three companies hereinafter collectively referred to as "JCB"), and PT Bank Danamon Indonesia Tbk (hereinafter, "Bank Danamon"), a subsidiary of MUFG Bank, Ltd., to provide a medical inbound tourism program targeting high-net-worth individuals in Indonesia.







Services Provided

Through this partnership, the following visiting medical services for Indonesian JCB card members will be provided at Tokyo Midtown Clinic and Nihonbashi Muromachi Mitsui Tower Midtown Clinic, both of which are operated by Advanced Medical Care Inc.

• Provision of physical examination services

•English-language preliminary interview, examination, and post-examination feedback

As a partner offering medical services in Japan, Noage International will establish a system that makes it possible for Indonesian members to continuously access medical care in Japan. Delivering trust and peace of mind with regard to medical services will allow the partnership to contribute to further raising the value of Japan visits envisioned by JCB.

Partnership Agreement Signing Ceremony Held in Jakarta

On May 21, 2025, the signing ceremony was held in Jakarta, Indonesia, for the partnership agreement also involving JCB and Bank Danamon.

The official announcement of this program—a collaboration involving various companies—was made in front of local media representatives and partner companies to publicize the launch of this new partnership on a broad scale.



■Background of Collaboration

JCB has partnered with nine companies, with major Indonesian financial institution Bank Danamon at the core, to issue JCB cards primarily to high-net-worth clients. In Indonesia, JCB is focused on providing singular Japanese experiences based on its unique "Japanese hospitality (OMOTENASHI)" under the key phrase, "SUGOI JAPAN."

The companies involved have agreed to collaborate as part of these efforts with the aim of providing JCB members in Indonesia with access to Japan's high-quality medical services.

Taking this collaborative agreement as a new step forward, Noage International will continue the steady expansion of its initiatives in Asia and then in the global market to deliver Japanese medical services to an increasing number of people.
